- b. **Discussion Item 2**: [Fundraiser Opportunities. This year we have created a Fundraising Committee. This team is tasked with launching monthly fundraisers.  - a. **Principal's Report**
 - i. Enrollment and/or Leveling Updates Our projected enrollment was 190. Our actual enrollment was 234, for a net gain of 44 students. We will receive an additional \$200,000 in the general school budget. We will use this money primarily, but not exclusively, to add a third 3rd grade teacher, to create a 2nd semester afterschool program for grades 3-5 that will focus on preparing our students for the EOG assessments and to increase the number of field trips our students in grades K-5th can attend.
 - ii. Strategic Plan and Performance Measures Update We reviewed our strategic plan (uploaded to the GO team website). Our goals are to increase the percentage of students scoring proficient in ELA and in Math, and to decrease the number of students who are chronically absent (10 or more days.)
 - b. **Milestones Data** In ELA, 13% of our grade 3 5 students were proficient or above last year, since 2019 (pre-Covid) the number of our proficient students are 7% lower in this subject.

In Math, 9% of our grade 3-5 students were proficient or above last year; we have added a math lab to help our students develop better math proficiency.

In science, 15% of our students were proficient.

On a more positive note, the number of students in the developing bracket is increasing and we are working towards moving some of these students into proficiency.
