IV. Discussion Items (add items as needed)

a. **Discussion Item 1: Continuous Improvement Plan.** The principal presented our Strategic Plan and Continuous Improvement Plan. Our <u>needs assessment</u> reveals that our students in grades 3 – 5 are not achieving grade-level Lexile levels withing their grade band, in math our students need more practice in applying procedural skills to real world problems and our chronic absenteeism rate has increased form 15% in 2019 to 48.3% in SY 21 – 22. (These documents are available on our GO Team Website).

Our <u>SMART Goals</u> are to increase the percentage of students in grades 3-5 scoring proficient or above in ELA from 13% to 18% by May 2023; to increase the percentage of students in grades 3 – 5 scoring proficient or above in mathematics from 9% to 20% by May 2023; and to decrease the percentage of students wo miss more than 10 days of school form 48.3% to 30% by May 2023.

Our <u>Action Steps</u> in the areas of curriculum, serving our subgroup populations, utilizing flexible learning tools and technology and targeted instruction, SEL implementation, our signature program and family engagement were discussed. (The document is available on the website.)

Balancing our schedule to add additional reading time to our schedule was discussed. We add reading to our other subject areas to increase their reading time and we ask for parental support to encourage students to practice these skills at home.

b. **Discussion Item 2**: **Fall 22 MAP Data** Because Milestones are only given annually, we use MAP three times a year to monitor literacy and numeracy. Our Whole Child (attendance) progress is monitored using the APSgraphs.com.

In Math, from Spring 2022 to August 2022, the number of our developing students increased from 35% to 46%. In ELA, over that same time period, our proficient students increased from 11% to 18% and in Fluency (Kindergarten and First Grade) our Proficient students increased from 30% to 49%. We are encouraged by this trend but we intend to be better.

V. Information Items (add items as needed)

a. **Principal's Report** Fall ACES: (Accountability, Collaboration, Equity, Support) highlights. Our enrollment is up 11 students. We have 2 first year teachers and one teacher vacancy (Spanish). We have 17 ELL students, 29 SWD students and



fewer than 10 gifted students. We only have 22% of our students who are chronically absent, which is a tribute to the hard work of Mr. Marshall our social worker. We are conforming to District standards in implementing our Intervention program.

b. **Rezoning meeting** [There are several new subdivisions being built in our zoning area, including both market value and affordable housing that are expected to add approximately 100 students to our enrollment over the next 3 – 5 years. We have the building capacity to support these students, and the increase in resources will be welcomed. Rezoning will be considered by the Board, but these developments have been anticipated for some time.]
