#### ARTICLE III: GO TEAM MEETINGS

Section 3.4. Public Comment. Opportunities for public comment shall be provided at least four (4) times in a school/fiscal year and noted on the meeting agenda. Public comment opportunities are available for GO Teams to hear from interested members of the community. GO Team members will not provide responses or engage in direct conversation during meetings. Each GO Team may determine a consistent method for receiving public comments and for parents and other citizens to sign up to address the team, provided that the team offer at least 20 minutes of time to the public to make comments, when available, and that the public receive at least 2 business days' notice of the protocol for signing up to speak.

The J.W. Dobbs GO Team welcomes and encourages citizens to attend its meetings to become better acquainted with the programs of Dobbs and the role of the GO Team. Unless otherwise provided by law, the GO Team meetings are open to the public. Citizens are welcome to attend the meetings but must refrain from interrupting or distracting the GO Team proceedings.

For those people wishing to provide comment, designated time periods for public comment are identified on each agenda

Twenty minutes have been allocated for public comment at the end of the GO Team meeting agenda.



Persons wishing to comment must sign up on the meeting day.

- Sign –up sheets will be available from 3:50pm 4:10pm
- Individuals wishing to make comment may only sign up once and may not yield to another person.

(A sign-up sheet will be available at the door and must be used by any person who wishes to speak during the public comment period.)

- Each speaker will be granted two minutes to make comment.
- The timekeeper will hold up a red card to give the speaker a 30 second warning.
- A timer will sound off once the two minutes has ended.

(At the close of the two (2) minute period, the speaker will be asked to take their seat so that others identified on the sign-in sheet can be provided an opportunity to speak.)

At the end of the public comment period, the period will be closed and the GO Team will move on to the next agenda item.

a. Communication Items

Ms. Ragin reminded staff and parents of the communication platforms available this year- school website, parent conferences, school Twitter account, parent liaison, emails, Remind 101

#### III. Information Items

- a. Principal's Report
  - 1. Data Conversation- Ms. Ragin shared Dobbs progress and content mastery percentages. We earned 81% progress points and 7% content mastery. We have some work to do in students mastering the standards but students are making progress. We also looked at ELA, Math, Science, and Social Studies achievement levels from GMAS and compared from 2018 to 2019 for 3<sup>rd</sup> through 5<sup>th</sup> grades. ELA moved from 15% to 17% proficient or above; Math 10% to 16% proficiency or above; Science 18% to 22%; Social Studies 9% to 3%. We looked at attendance data. Our attendance rate was 99.5%. Our suspension rates went up from last year but there were extreme behavior circumstances with our fourth and fifth grade student that needed to be controlled. The latest climate rating of 3.0 was from 2018. We do not have our 2019 rating. Our goal is to be a 5 star school.
  - 2. **New for Dobbs** Ms. Ragin spoke of the changes to teacher's schedules for this year, particularly our planning structure. Teachers have a 90 minute Math block, 120 minutes for Reading/ELA. This will allow implementation of a new reading program, Fontus and Pinell that will have a more focused approach. Changes to the teacher's planning include one 90 minute block were as it use to be broken into (2) 45 minute blocks.
  - 3. **Leveling Information** We earned 2 additional staff, one that starts on Monday, however, one candidate resigned. Fifth grade needed an additional staff support due to higher enrollment and lower data.
