a. FY 16-GMAS Data Review (Mrs. Crooms) presented in powerpoint BMS Statistics regarding:

- Examined demographics/data for BMS with copy of Powerpoint provided in each folder (as shown on active panel)
- (Crooms) discussed how data had changed in presentation from last year (district) and does not include updates since redistricting.
- 80-90% of student population @ BMS (bused in); 2-3% live in neighborhood
- GO Team discussed and agreed a lot of support and work are needed especially in (Math/Reading) based on data.
- 8th grade will be evaluated in all content areas regarding (2017 GA Milestones Test)
- CCRPI (more info will be forthcoming at Dec meeting);
- goals discussed to push out more students (inclusion) 80%;
- 1/3 Spec Ed population @ BMS (33% @ BMS, higher than Nat. Avg.)
- Additional SEL (Social Emotional Learning) needed
- 95% goal for attendance rate, currently @ 92% rate

- @ World Language Courses offered @ BMS (30 students) possibly earning credit towards CCRPI
- STEM Program req. teacher to be HQ in content area (Science/Math); (on track for 2019)
