VI. Discussion Items

A. King's Strategic Plan

- All Data and Goals are from 2019
- The school's goal & the districts norm is to have at least 3% growth in each subgroup.
- Full-Time Instructional Coaches available for all content areas except in World Language.
- Map, Read180, Math 180, and Universal Screener is the only real & up-to-date data since 2019.
- Once a week, SEL is implemented.
- Universal screener will be implemented twice a year.
- o Emory, HBCU's, and Georgia State Mentorships will continue.

B. Universal Screener

- 254 Sixth graders, 291 seventh graders, 260 eighth graders were screened. (About 97% of the student body).
- 41% of sixth grade students are at the beginning range for reading.
- 45% of sixth grade students are at the beginning range for math.
- 45% of seventh grade students are at the beginning range for reading.
- o 50% of seventh grade students are at the beginning range for math.
- 35% of eighth grade students are at the beginning range for reading.
- 47% of eighth grade students are at the beginning range for math.
- All subgroups except students with disabilities and English language learners are roughly at or around the district average.
- Students with Disabilities and English Language Learners need the most improvement to meet the district average.
- BASC-3 BESS Universal Screener just screens students, doesn't diagnose them.
- Students, parents, and teachers completed the screening between September 16th and October 1st.
- o 775 students, 40 students, and 18 parents completed the screener.
- 77% of students who were screened were in the normal range, 10% fell in the caution range, and 13% were in the extremely elevated range.
- Reports will be sent home within a few weeks.



C. Milestones

- Data from the 2021 milestones should not be used to compare year over year trends at either the district or school level as the students tested in 2021 were not representative samples of all APS students.
- Only 25% of the student population took the most recent milestones.

D. Leveling

- School is slated to lose one Special- Ed teacher.
- Money within the budget will be allocated to save the teacher's position.
- Part of the cares funding will be used to hire a front office clerk.

- A student has made a threat to the school for Friday October 15th.
 Student has been suspended and is awaiting tribunal. Safety measures have been put into place for that date.
