IV. Discussion Items

- a. **Discussion Item 1**: Long Middle School strategic plan was discussed. Ms. Hill shared old strategic plan with previous priorities (academic program, talent management, systems and resources, and culture) from the last 5 years. The plan was updated in March 2021 to include STEM implementation. During this time, the mission and vision was updated. Priorities stayed the same but some of the school strategies changed.
- b. **Discussion Item 2**: New strategic plan shared. The mission and vision was updated previously. The SMART goals were aligned to the district goals. A fourth SMART goal is still needed. The team discussed that the 4th goal should focus on culture, but it must be measurable. Ideas around SEL, discipline, and family engagement were some thoughts. The new plan includes new categories of APS strategic priorities and initiatives. Categories include fostering academic excellence for all, building culture of student support, equipping and empowering leaders and staff, and creating a system of school support. Each school strategic priority was discussed in detail. Team need to construct a priority around "goal setting, student ownership, and growth mindset." Should be constructed by next meeting.

V. Information Items

a. **Principal's Report** Ms. Hill shared that there was a notice from the EPA about a business behind the school. EPA investigated TPA Holdings. During investigation, EPA found traces of lead in the stream that flows behind the school. EPA ceased operations until matter is rectified. In the meantime, parents were notified, the notification was posted on the school website, and 4 areas on Long Middle property were taped off. As of now, there is no imminent danger posed to Long, but EPA is testing the property of Long. There will be an update in February.
