IV. Discussion Items

- A. **Discussion Item 1:** Communication Plan – Dr. Jones discussed the information that has been shared with families using school resources such as robocalls, BEST App, and the school website.

V. Information Items

- A. **Return + Learn Plan** Mr. Williams spoke about the Return + Learn Plan that was used on Day 1 as a form of communication between the district and families. He explored informational tabs such as transportation, nutrition, technology and other departments.
- B. **Principal's Report** Dr. Jones shared information about the Class Master List and Virtual Parent Center that was placed in students' Mybackpack. He discussed the One Stop Shop Zoom call for families to connect with various staff members for the first two weeks of school. Mr. Strickland mentioned his concern regarding the social and emotional needs of students from parents. Dr. Jones discussed Advisement SEL activities for students as well as the In10ionality Awards for students/staff, which are given weekly at Fresh Start Monday.

Mr. Glover stated that he has been happy with the service (teacher/parent liaison) his family has received from the school. He stated that one area of concern he has is for students who may have technical issues before a class begins and is marked absent. Mr. Williams suggested the administrative team share a protocol with teachers so students can perhaps email me their teacher if there is a technical issue or unable to login to Zoom.

VI. Announcements

- A. Dr. Jones gave candidates an opportunity to speak to the GO Team and share their interest in becoming a member. Afterwards, Mr. Strickland asked the members if there was anything the school could do better.
- i. Latonia Kurtz (parent) shared that she has a 7th grader and is an advocate for all students including students with special needs. Ms. Kurtz

indicated that teachers could be more patient with the middle school students.

- ii. Ruquanda Epps-Primas (teacher) shared that she believes in the mission of BEST Academy and wants to contribute in any way possible. Ms. Epps-Primas stated that BEST Academy could focus more on SEL with our students given the challenging times.
- iii. Kenya Gilliard (parent) shared that she has an 8th grader at the school and wants to contribute in her child's education. *Dr. Gilliard arrived on the call after Mr. Strickland asked candidates to identify developmental areas.*
