October Meeting Minutes

I. Call to Order:

- Continuous Improvement Plan/Principal's report by Dr. Jones. School initiatives present— Computer Science Pathway
- Dr. Patterson spoke about Gettysburg field trip—24 students attended, well behaved; event organized.
- All Pro Dads Event successful with 40 in attendance.
- Truist Bank will sponsor a reality check program to help students manage their financials.

V. Information Items

• Enrollment is currently at 247 (2 new students); the enrollment does not impact leveling.

Comprehensive School Plan

- COMPREHENSIVE SCHOOL PLAN presented by Guest speaker, VP Kelley. The five-check program goes over areas of challenges: Literacy, ELA, Numerology. Whole child, and student support (6 goals because of MS & HS)
- SMART GOALS were given for each area; increase 12% for ELA/Literacy
- Dr. Smart asked about breakdown of students from the 244 number given earlier that could be used for the SMART GOALS

GMA Results

- These were explained by VP Kelley and Dr. Jones
- Questions were asked and answered by Dr. Gilliard (What contributed to the gains) (change of staff and leveling students to the right class
- 6th grade math grades were explained—lower number of students at the time of the test and the IEP were for 50% of 12 students who took the test.
- VP Kelley continued to explain the Grows and Glows for the report

Dress Code

- VP Guilford discussed school dress code, expectations, and comparison to last year.
- Last year was more relaxed; this year the dress code will be enforced with consequences.
- 98% MS in dress code; 91% HS in dress code
- Biggest issues: Croc shoes, hoodies, and tops with hoodies. Solution: be more specific with rules like adding zipped hoodies with school logo and pull over hoodie with school logo. Shirts can be worn over hoodies to stay in compliance.
- Letters are given to students who are out of compliance; Administration is taking extra precautions and enforcing school uniforms; this is a safety issue and keeps the campus safe and in order.

Dress Code

- #8 no appearance enhancements may NOT be worn at school; no earrings (MS); no hair extensions or wigs. Vote accepted to leave it.
- #4 remove DECORATIVE orthodontic appliances—change to No removable decorative appliances or grills. Vote accepts to this change to #4. Add to the bottom "including school trips, field trips and events"
- Request made to send final version to the Legal Department to verify Board's school policy.
- Discrimination Policy--Request to add rationale for it. Accepted Dress Code Policy as amended
