V. Discussion Items

A. School Strategic Plan

i. Strategic Plan & Priorities Review

This Strategic Plan was developed several years ago and expires in 2025. Question raised about counselors and has MHS done this before. Administration says yes and that co-teaching helps with this process. It will be determined what training counselors will go to based on what training they've completed in the past. Attendance brought up. In the recent past, an attendance coach was paid for by CARES funding. That position is going away as CARES expired; the attendance coach worked with a social worker and coaches. Coach Hill will be working with the athletes. There will be case managers for special education. Attendance at MHS is better than other APS schools hasn't come back, post COVID, for special ed students. The attendance team is now comprised of specific support staff, which includes a social worker. Other populations within MHS with attendance issues are those with 504s.

ii. SMART Goals

Graduation Rate: Today the graduation rate was received but is embargoed – MHS is on track to meet the goal. Mechanism for determining staff satisfaction: we do have the Gallup Surveys. Teachers want more participating in decision making. Design team received feedback from teachers on the difficulties of teaching at Midtown. (Used the design team first for overcrowding but it started to uncover other issues that would make it easier to deal with the overcrowding – this is what led to the cell phone policy, and grading policy). Will be working with a consultant on executive functioning skills to help teachers on the 14th.

Parent Participation: parent conferences would count, curriculum night, etc. Background: these are mainly around different subgroups. Can look at information dissemination. Can look at contact log in IC; QR codes. We need to keep this because this is required for subgroups.

B. Data Discussion

How many MAP tests will be administered? Some student groups were allowed to opt out of the December test. Will continue to think of this as optional unless told otherwise. Gaps in some of our 11 graders in AP physics, calculus, AP stat. This group learned a lot of science and

math online. This year added physical science class (could take physics or physical science). Longitudinal cohort data could be helpful to illustrate current and potentially upcoming problem areas. Opportunity to use decisions and strategies that worked to bolster strategic plan update. (Example: Using the attendance coach helped attendance to rebound)
