- c. **Discussion Item 3**: 2019-2020 Strategic Plan Review: A copy of school's strategic plan was distributed. The achievement levels were discussed with GO Team members for understanding. The plan was created and revised in March. Specific priority areas are centered on ELA, Math, and STEM. Action steps are day to day communications to meet schoolwide goals. Our goal is to be STEM certified by 2020 school year. Teachers have been in trainings and workshops to support STEM certification.
