Discussion Item 1: Year in Review Attendance

Meeting Minutes



- Ms. Stifler shared visuals of our attendance compared to other Partner schools, KIPP schools, and our cluster. KWPA's attendance is improved by 9% than last school year, but below the 70% regional goal, and 75% KWPA goal. There are still days left to encourage families to come–incentives included–to ensure we get above 65% for the year by the end of the year
- The team also reviewed attendance percentages by grade level and noted that Kinder 2nd have struggled all year

Discussion Item 2: Year in Review MAP Data

• The team reviewed high-level MAP data by content K-8 and then grade (reading and math). Proficiency levels are too low but the team is ready to dig into growth data to ensure scholars hit growth goals that stay with us the bulk of each year. Year over year growth will ensure scholars get to proficiency over the course of multiple years
