- i. Ms. Graham asked if the team had any nominees or ideas. No one responded. Ms. Graham charged the team with ensuring that we try to bring a nominee to our December 2nd meeting

## II. Discussion Items

**A. Discussion Item 1: Uniform Discussion**

- i. Ms. Graham presented the team with the current uniform at KWPA for all grades and said that today the team would make a decision about the uniform for the next school year–SY25-26. This would be do we decide to continue, to alter, to not have one, and what to implement for the next school year. Ms. Graham shared that if we vote in favor of the uniform then we will have an advisory committee and if we vote against it, the school will not have a uniform for the next school year. She then opened the team up to the idea
- ii. Ms. De la Cruz voiced that we should keep the uniform
- iii. Ms. Thompson seconded that idea.
- iv. 0 teammates disagreed or were neutral, after Ms. Graham asked.
- v. So Ms. Graham stated that the motion to have one (keep) was made and seconded
- vi. Dr. Lyon added that he thinks it is more cost effective & good for parents
- vii. Ms. De la Cruz said that she agrees it is easier for parents as they don't have to worry about what to wear and for the school to keep the uniform simple

- viii. Ms. Graham stated that she also thinks it lessens the amount of bullying at school
- ix. Mr. R said that he also thinks it creates unification across the K-8 campus, as scholars work towards wearing the special 8th grade polo. Mr. Lyon said maybe we can make it so that the 8th grade polo is completely different so that scholars look up to it and really want to be in 8th grade.
- x. 100% of voting members voted in favor of a uniform
- xi. Ms. Graham then read the details of the uniform committee & stated that we had to have 3 Go Team Members and 3 students and that the team would ask for feedback, do some research, and present a recommendation
- xii. Ms. Graham accepted being the Chair of the Uniform Committee and Ms. Thompson and Ms. De la Cruz said they would be on it
- xiii. The team said yes to having older primary scholars on the committee and middle school scholars as well. Ms. De la Cruz recommended us asking scholars who are consistently in uniform as well as high Live School balances to be on the committee, and that in primary it should be older scholars (3rd-5th)
- xiv. The next date of Go Team is December 2nd, 2024, so Ms Graham committed the committee to presenting the findings at this meeting and the Go Team making a decision by the following day, December 3rd, 2024

**B. Discussion Item 2: [Science Fair](#)**

- i. Dr. Lyon and Ms. Graham presented an overview of the Science Fair coming up and their hopes for this year—more participation, more actual science projects (asking a question), having guest speakers, offering scholars to stay after school for support. Ms. Graham asked for additional ideas.
- ii. Ms. De la Cruz asked about the sign up process and Ms. Graham stated that it was not mandatory.
