V. Information Items

- a. 4th Quarter In-Person Updates
 - i. 101 total students returning face-to-face (35%) starting March 22nd
 - ii. One concern is the high number of telework staff members and ensuring the class sizes stay small
 - iii. Parents are asked to come to Dunbar on Fridays to pick up PPE and complete documentation
 - iv. Students are stationary throughout the day and join Zoom with their teachers
- b. GO TEAM Declarations
 - i. Dunbar needs another parent and another staff member to join the team
 - ii. Ms. Jones declared for another term
 - iii. Declarations need to be made by Monday
- c. APS Summer Recovery Program
 - i. Still in the planning stages
 - ii. Host sites for Jackson cluster are Parkside and Burgess Peterson
 - iii. Students will have to be bused
 - iv. 4 weeks, full day (month of June)
 - v. Focusing on reading and math
 - vi. Xanadu and ESY will occur
 - vii. Kindercamp full day at Dunbar (month of June) for rising and current kindergarten students
- d. CARES II Funds
 - i. Dunbar is allocated \$185,220 in federal funding
 - ii. Funds must be used on item aligned to implementation of school-based intervention block
 - iii. Securing iReady (Reading and Math) for all students which is an adaptive program
 - iv. Securing a full-time paraprofessional (1 year only)
 - v. Funds for "other allowable expenditures" can be used for technology, mental and physical health, supplemental learning, professional development, at-risk populations, continuity of core staff services
 - vi. Dunbar will be utilizing the "other allowable expenditure" CARES II funds for:
 - 1. Afterschool intervention learning academy
 - 2. Tutorial services
 - Online web-based programs
