c. Calendar of events

IV. Discussion Items (Continuous Improvement Plan Process/PBSA R3 Updated)

- a. **Discussion Item 1: [Price Reading Rollup]** Our projections for Proficient and Above are slightly below last year's levels overall and by grade level, though Grades 6 and 8, along with Students with Disabilities (SWD), are outperforming their cohorts from last year. Price's Fall-to-Winter Median Growth in reading is average overall, with significant variation: Grade 7 shows strong growth, Grade 8 shows average growth, and Grade 6 shows low growth. Students in Tiers 2-4 are experiencing higher growth than those in Tier 1, while those who received ReadSource are growing more than those who did not. Students receiving GAP services are growing less than their peers reading.
- b. **Discussion Item 2: [Math Rollup]** Projections for Developing and Above are slightly below last year's levels on MAP, with Grade 6 and Grade 8 outperforming last year's performance, while Grade 7 is underperforming. For Proficient and Above, projections are the same or slightly above last year's levels, particularly in Grades 6 and 8. Price's Fall-to-Winter Median Growth in reading is average overall, but with significant grade-level variation: high growth is seen in Grades 6 and 8, while Grade 7 shows low growth. In Math, students in Tiers 2-4 are showing higher growth than those in Tier 1. Students receiving GAP services are growing similarly to their peers overall, though 8th Grade GAP students show notably higher growth.
- c. **Discussion Item 3: R3 Data Processed/ 2nd Semester Focus – Goal 1]** By May 2025, 75% of students will meet the CCRPI attendance standard, with 65% meeting it by December 2024, and 100% of students will be accounted for daily. In ELA, students scoring Developing and Above will increase from 53% to 60%, and students scoring Proficient and Above will increase from 15% to 17%. By May 2025, teachers will integrate at least two writing strategies into the curriculum across all content areas, and students will proficiently respond using a constructed response based on the writing rubric. By December 2024, teachers will provide evidence of student writing in daily

observable instruction, and 100% of teachers will incorporate weekly constructed responses in all content areas. We will continue with our current Academic Practices, but with increased consistency and intensity. This includes enhanced Writing Integration, Vocabulary development, Differentiated Small Groups, and showcasing Performance Tasks and Student Work Displays. All previous steps will continue.

- d. **Discussion Item 4:** We are refining teacher lesson planning to ensure uniformity, consistency, and alignment, which will lead to improved student outcomes. This includes a focus on Writing and Vocabulary, as well as Differentiated Small Groups.
