**Information Items** 

#### Principal's Report:

Preparing for our quarter 4 term. Looks like we will have 76% return in person (up from 70%). If things hold where they are, we can continue with our current instructional model. Asynchronous Wednesdays will continue for the reminder of this school year. This is a district wide decision. These Wednesdays are helping teachers with their planning time. 5 days/week in person instruction is a concern for many families within the N Atlanta Cluster. There is continuing discussion about what next year will look like (ie - 4 days in person, 1 asynchronous/ 5 days in person, etc). Wednesdays may not be asynchronous, but not sure what they will look like. Community Conversation will be happening this week. NAPPS Principals meeting coming up on 3/25 at noon. North Atlanta Cluster mtg is 3/17 from 5-7.

It is concerning that private schools are using the 5 day in person as a marketing tool. We are hoping the district makes an announcement soon about what the school week will look like next year so families can plan what's best for them.

Can we do something cluster based vs district wide in terms of being in 5 days? We can't force DLI families out of the program because they have a health concern with coming back in person. DLI is the only one that may have simultaneous virtual and in person.
