IV. Discussion Items

- a. Discussion Item 1: Georgia Milestones Math Data
 - i. Significant increase in scores from '22 to '23 and green zone improved by another 2% in '24; at a grade level review can also review trend by cohort and demographic; *note last year standards, curriculum, and resource changes occurred
 - an opportunity here for DLI students to bridge math in English along with Spanish, similar to Science; ESOL teachers supporting DLI teachers in math lessons (4 FT teachers supporting this)
- b. Discussion Item 2: Access & Lexiles Data
 - ACCESS test is 1x/year for ELL students tests listening, speaking, reading, writing over the course of 4 days testing growth in English, this helps determine skillset and once they reach a 5.0 composite score they graduate from ELL (6 point scale); 2022 61% of students moved up one band, 2023 71% of students moved up one band (123 students in 2024, 20% of school population)
 - ii. Lexile Level helps determine students reading level built from the Georgia Milestones scores, with us coming in under goal (question accuracy of goal/standard)
- c. Discussion Item 3: Continuous Improvement Plan Presentation
 - i. Do we want to change any of the priorities
 - 1. Add strategies building on science for priority #1
 - 2. Adjust 4. "Build teacher capacity in literacy, match & science"
 - 3. What is teacher capacity? Training of the content and how to teach the content (4D)
 - 4. Tabled conversation of science teacher and/or coordinator
 - 5. Added "teaming" in 4th and 5th grade, which allows teachers to specialize in subjects
 - ii. Brief re-overview of Dr/ Waller's offline CIP
 - iii. Conversation around PLC, best practice documentation and what is being used now + opportunities - previously used a consultant to help build out PLC's

i. <u>Facilities Usage - BOE doc</u> (linked) shows how much school usage is compared to capacity, in North Atlanta cluster our utilization is 87% which is highest of North Atlanta elementary schools. Enrollment trend for APS schools is on a decline. Combining lower utilization schools is a last resort; includes projections out to 2032 with highest growth for E. Rivers
