Top Priorities for Schools

1. **High-Quality Teaching** – Ensure consistently strong, well-supported educators in every classroom.
2. **Instructional Practices** – Provide effective and engaging strategies and materials tailored to diverse learners.
3. **Rigorous and Relevant Curriculum** – Offer curriculum that is challenging, meaningful, and aligned with real-world skills.
4. **Whole Child Learning** – Support students' social-emotional, academic, and physical development.
5. **Support for Diverse Needs** – Meet the unique learning needs of students with disabilities, English learners, and other vulnerable groups.
6. **Equity and Inclusion** – Foster fair access and respectful learning environments for all students.
7. **Career Exposure and Pathways** – Equip students early with practical skills and options for college, careers, or trades.
8. **Assessment and Accountability** – Use fair, reflective metrics to measure progress and leadership performance.

2. **Data-Informed Systems and Program Evaluation** – Use robust, transparent data systems for continuous improvement, program evaluation, and strategic decision-making.
3. **Mental Health and Wellness** – Expand access to emotional and mental health services.
4. **Policy Review** – Update district policies to reflect equity, whole-child development, and current needs.
5. **Staffing and Scheduling** – Ensure strategic allocation of staff and instructional time.
6. **Life Enrichment Spaces** – Invest in non-academic learning environments (e.g., arts, recreation).

7. **Transportation Equity** – Make all programs and schools accessible regardless of a student's zip code.

7. **Cultural Respect and Appreciation** – Build trust through inclusive practices that honor all cultures.
8. **Shared Responsibility** – Position families as co-educators and partners in student growth.
