


#### Definition of terms

- **Potentially Excess Property** 47 properties not currently in active use, as determined by APS; these are the properties that Sizemore is reviewing for "hold" or "disposal."
- **Disposal** Sale or exchange of property (no longer hold title to the property). No longer hold for active use.
- **Surplus** A declaration by the Board of Education designating possible future disposal of properties.
- Hold Maintain ownership for active or "reserve" Atlanta Public Schools use.
- Unused- term used in the law to provide a property to a local charter school.


# Policy wording

• "Surplus" ...available for sale ("Disposal"- No longer owning) or lease (continue owning) is at variance with Surplus as used in this presentation

# Scope & Flow: Review of potentially excess properties



#### Problem Statement

#### **Problem Statement:**

- APS must accommodate future student enrollment.
- APS owns properties including unused facilities & land.
- APS will use the outcome of this analysis to inform them on how to strengthen communities (such as by providing affordable housing, art centers, community centers, workforce housing, etc.).


#### Therefore, the plan needs to focus on:

- Holding properties needed for future enrollment within each cluster.
- Identifying properties for potential disposal.

## Proposed Methodology

- Sort and Hold properties which are currently and actively being used by APS
- Declare the remainder "Potentially Excess" and determine 4 Criteria for each:
  - Determine the Utilization of each Cluster based on 2050 ARC Population projections and the total Active Capacity of the school facilities in each Cluster
  - Determine the **Obvious Risk Hazards** (as defined by Georgia Department of Education) of each Potentially Excess Property. (Detailed Risk Hazard Assessments will need to be done on each site considered for an Education site)
  - Determine the **Size** of each Potentially Excess Property
  - Determine each Potentially Excess Property's **Proximity** to existing elementary schools
- Determine a Weighting Value for each Criteria
- Rank the future desirability to APS of each Excess Property based on their Weighted Score



## All APS properties

Atlanta Public Schools owns

152 properties most of which have active use, and some of them may be in excess of the future needs



#### Definition of terms

- Active Non-Educational Leased APS Properties which are leased as training facilities to other Governmental Agencies such as the Atlanta police and fire departments and WABE Broadcast Studios.
- Active Administrative APS Administrative sites, Adult Education, Testing Center, teacher training, Service centers, Transportation Centers.
- Active K-12 APS K-12 Schools currently in-use by APS.
- Active K-12 APS (Relocation) Administrative Relocation, Elementary School Relocation site, Storage.
- Active Early Education Leased Properties which are currently in-use as Early Education sites and which are operated by organizations outside of APS.
- Active Educational Leased Properties which are leased to independent K-12 educational organizations, principally Charter Schools.
- Active K-12 Support APS Properties currently used by APS for support operations such as Digital learning centers, bus parking and maintenance, and after school programming, and Athletics Facilities, Stadiums.

#### Definition of terms

- •Inactive Reserve Land Properties without any buildings/improvements.
- •Reserve Building Properties with current use such as storage location, recreational field/site, and community use plus other properties which may be currently vacant.
- Reserve Land Potential or current Community Park, recreational sites, wooded sites adjacent to active facilities.
- •Undersized Land Adjacent Small sites adjacent to currently active K-12 schools.
- Undersized Land Non-Adjacent Relatively isolated small sites.
- ARC Atlanta Regional Commission. The Atlanta Regional Commission is the regional planning and intergovernmental coordination agency for the 10-county Atlanta region.
- **Proximity** Closeness, a definition of how close a potentially excess property is from other APS Properties.

ARC Household Growth Forecast by Census Tract, 2030 - 2050





Bass Field is located in the Midtown cluster which is projected to be overcrowded in 2050. Scored 0 out of 4 with high score favoring possible disposal.




#### Criteria # 2: Excess Sites with Risk-Hazard Issues

Bass Field is close to a Railroad, a State Highway and a 100 kVA Power Transmission Line.



- Other factors may make a small site desirable for school use:
  - Adjacent Park
  - Location in High Growth Area
  - Distance from Other schools
- Other school uses may be needed



#### Bass Field – Criteria #3: Site Size


The Bass Field site is 4.8 acres in size, between 2.6 and 5.0 Acres. Scored 2 out of 4 with high score favoring possible disposal.

## Criteria #4: Proximity – Potentially Excess Properties

- Potentially Excess Properties within 1 or 1.5 miles walking distance of another school may be too close to be useful as an Elementary School site.
- Properties within 1 or 1.5 miles of another Potentially Excess Property may be redundant. Perhaps another nearby property is a better choice for use as a school site.





#### Proximity to other Potentially Excess Properties

- Excess Properties closer than one mile from another Potentially excess property
- Excess Properties between 1 and 1.5 miles from another Potentially excess property
- Excess Properties further than 1.5 miles of another Potentially excess property

## Bass Field – 4B Proximity to other PEP

Bass Field is within 1 to 1.5 miles walking distance of the closest other Possible Excess Property. Scored 2 out of 4 with high score favoring possible disposal.



## Weighting Values of Four Criteria

- 1.The Greatest Weight (45%) is given to the Utilization of each Cluster.
  - Elementary schools are considered the primary building block of each cluster.
  - Middle Schools and High Schools may be expanded if the site allows it, or Elementary schools might be redistricted from one cluster to another to allow for growing high school and middle school enrollment.
- 2.Risk Hazards are the second most valued criteria (30%).
  - While some Risks can be mitigated by the design of the site and building, they represent a limitation at least and a possibly prohibitive criteria at the most severe.
- 3. Property Size & Buildable area (15%) while some sites are very small,
  - They may add to and support an existing site, or
  - They may be supplemented by parks or community centers
  - They may be used for administrative services
  - APS operated the Campbell Elementary at 1.5 acres and are now operating Hope Hill with a 1.8-acre site
- 4.Proximity (10%):
  - A. Sites which are isolated from other schools, but in a potentially residential area may be useful, no matter the size. Proximity from Active Elementary School (5%)
  - B. If two or more excess properties are close to one another, only one should be chosen to be developed as an elementary school. Proximity from another Potentially Excess Property (5%)
