



Construction Activities this week

- 85% COMPLETED WITH STORM LINES/STRUCTURES.
- 100% COMPLETED WITH OPERATIONS BUILDING PAD.
- CONCRETE PIERS/SPREAD FOOTINGS ARE INSTALLED.
- ELECTRICAL UNDERGROUND ROUGH-IN'S ARE 75% COMPLETED. TASK IS ONGOING.
- SS BORE ACROSS MAYNARD STREET WORK REMAINS ON HOLD TILL FURTHER NOTICE.
- BACKFILLING OF THE RETENTION POND **100%** COMPLETED.
- FIRE RISER PIPING TO OPERATION BUILDING STUB-IN HAS BEEN RAN.
- 100% of Mass Grading for Laydown area is complete. Equipment and Conex Boxes have arrived onsite. Gravel to be laid on (01/29/24)
